### ELIGIBILITY AND ENROLLMENT REQUIREMENTS

This offer is available to new residential customers only and applies to service agreements signed during the month of July. To enroll in this offer, the following requirements must be met at the time of enrollment and maintained for the full term of the agreement:

- A valid credit card must be kept on file with Pest Stop Services.
- The customer must be enrolled in monthly autopay for the full 12-month term of the agreement.

### PEST WARRANTY

Pests covered under this agreement are warrantied for the life of the 12-month agreement, provided that any conducive conditions identified by the Pest Stop technician and recommended for correction have been addressed by the customer.

If recommended conducive conditions are not corrected, warranty coverage may not apply to pest activity directly related to that uncorrected condition. The technician will document any conducive conditions noted at the time of service.

### CANCELLATION AND EARLY TERMINATION

The customer may cancel this agreement at any time by providing 30 days written notice to Pest Stop Services.

If the customer cancels before completing the full 12-month term, the customer agrees to reimburse Pest Stop Services for whichever of the following two amounts is less:

- The dollar value of the discount received on the initial service under this promotion, OR
- The total amount that would have been billed for the remaining unfulfilled months of the agreement.

Pest Stop Services will calculate the applicable reimbursement amount and provide it to the customer in writing at the time of cancellation.
